



Oklahoma Cares Helps Oklahoma Women With Breast Cancer

OKLAHOMA CITY – Oklahoma Cares, a program for lower-income women with breast or cervical cancer, is currently helping more than 2,800 women across the state.

Oklahoma Cares is a partnership of the Oklahoma State Department of Health, the Oklahoma Health Care Authority, the Cherokee Nation, the Kaw Nation of Oklahoma and the Oklahoma Department of Human Services. The program allows eligible women to receive full SoonerCare (Oklahoma Medicaid) benefits for the duration of their cancer treatment.

In order to become eligible for the program, women must be screened for breast or cervical cancer under the Breast and Cervical Cancer Early Detection Program (BCCEDP) and found to have either an abnormal screening result or precancerous condition or to be in need of treatment for either breast or cervical cancer.

According to federal eligibility guidelines, women also must be under the age of 65, have no creditable health insurance coverage or other available insurance providing breast or cervical cancer services, including SoonerCare, and meet income guidelines.

Women who are interested in participating in Oklahoma Cares should ask their health care provider if he or she is a certified screening provider. If not, they can find a screening provider in their area by contacting the Oklahoma State Department of Health at 866-550-5585.
